The Portal is an application accessible via the Internet which provides the possibility to create service tickets for further products and services of BHS CORRUGATED ("BHS CORRUGATED Products").
- 2. The use of the Service-Ticket-Portal requires the successful registration of the User. By registering, the User accepts the validity of these Terms of Use, which can be called up and printed after registration.
- 3. The User assures to have provided all data truthfully and completely within the registration. BHS CORRUGATED reserves the right to delete the access of a User for good cause after previous unsuccessful warning. An important reason is in particular the improper use of the Service-Ticket-Portal or a violation of the Terms of Use.
- 4. The use of the Service-Ticket-Portal is free of charge. For the use of further products and services of BHS CORRUGATED their separate Terms of Use and their contractually agreed prices apply.
- 5. BHS CORRUGATED reserves the right to make technical and content changes to the Service-Ticket-Portal and these Terms of Use and will inform Users about the changes and their effective date in advance. These changes do not affect individually agreed contractual agreements between customers and BHS CORRUGATED regarding products and services of BHS CORRUGATED.
